# Nesma Security Awarded King Fahd Causeway Project



Nesma Security has signed agreements for several important projects, including a contract from the King Fahd Causeway Authority to provide security and safety services on the Saudi side of the 25km-long, King Fahd Causeway.

The project, valued at SAR1.8M, starts in February 2020 and will require 22 Saudi guards.

King Fahd Causeway has linked the Kingdom of Bahrain with the Eastern region of the Kingdom of Saudi Arabia since 1981, and was built to form long-lasting bonds between Saudi Arabia and Bahrain.

Additionally, Nesma Security was awarded a SAR 13.7 million contract with Tecnicas Reunidas at Haradh village in Al-Hasa.

Nesma Security will provide security and traffic services at the Haradh and Hawiyah gas compression project with a total manpower of 63 Saudi guards for the 21-month project.

Showtimes and bookings will be available soon on a Mobile App for all Jeddah-based Nesma companies.



### *Nesma & Partners To Be Part of First Nuclear Power Generation Plant Project*



Nesma & Partners signed several agreements with Electricite De France (EDF) to participate in the first nuclear power generation plant project in the Kingdom.

Five nuclear plant technology provider countries (USA, Russia, China, South Korea and France) are participating in the project which aims to provide support in a variety of ways including the RCC Academy, a training service set-up to spread knowledge of the Nuclear Regulation Construction Code (RCC). The RCC Academy was established under a protocol signed between EDF, Nesma & Partners, AFCEN (a nuclear code editor from France), Bureau Veritas (training leaders from France) and the Saudi Zamil Higher Institute for Industrial Training which provides vocational training locally.

The first session of the RCC Academy, held over a period of 3 days, was conducted at Nesma & Partner's Head Office.

### Mawaddah Signs with Malaysian Consulate in Jeddah

Mawaddah signed a contract with the Malaysian Consulate General in Jeddah to provide Hajj facilities to the Malaysian Pilgrims during the upcoming Hajj season.

Mawaddah signed its first Hajj agreement with the Malaysian Hajj Commision in 2017, and since then, it continued to grow its market share in Malaysia and the rest of the world for Hajj and Umrah services.



### Namma Signs Contract to Transport Sudanese Pilgrims

As part of the early preparations for this year's Hajj season, Namma International Marine Services signed a contract with the Sudanese Supreme Commission for Hajj and Umrah.

Namma will transport 20,000 pilgrims to perform the annual pilgrimage to Makkah in 1441 AH.





# Amanah Vessel Transports More than 19,000 Passengers

Namma Tours vessel, Amanah, transported a total of 5000 pilgrims during the first month of Umra season.

Amanah also transported a total number of 19,592 passengers, 942 trucks and 316 cars during December, 2019 and January, 2020.

Namma Tours is a Cairo-based travel agency that offers travel packages for Egyptian pilgrims looking to visit Makkah and Medina with a fleet of vessels that include Mahabbah, Masarrah, Amanah, Roro, Alnawa Express, Namma Express and Aziz Express.


